# 5. REF Applications

a. City REF 2012-017, City of St. Albert - Proposed Municipal Development Plan amendment The Chair stepped down as Chair to represent the City of St. Albert. CRB Vice Chair, Mayor Berube assumed the Chair. Mayor Crouse introduced the item. Mr. Patrick Draper, City Manager from St. Albert made a presentation providing an overview of the MDP amendment highlighting the Plan's compliance with all requirements of the CRB's Growth Plan and the Regional Evaluation Framework (REF). Ms. Carol Bergum, Manager of Planning and Development and Mr. Marcelo Figueira, Senior Long Range Planner were also at the table.

A sub-committee of CAO's was convened on November 6, 2012 to review REF 2012-017. The Sub-committee did not reach unanimous consensus.

Mayor Rigney put forward a motion.

**Motion:** That the Capital Region Board Table Motion 5 (a) until such a time that St. Albert can include within its application the findings of a Statutory Public Hearing, providing feedback from area residents and landowners, provide assurance that a density of 30 to 45 homes per hectare will be achieved, the Minister endorse the board's legal opinion regarding the IDP matter and that it come back to the board once St. Albert has reconsidered whether they wish to proceed with amending the IDP as planned, or adopt the essence of the IDP as an MDP appendix.

# **Moved by** Mayor Rigney.

5 in favour, 19 opposed. Not supported by 17 or more municipalities comprising more than 75 percent of the population. **Motion failed.** 

Neal Sarnecki gave an overview of the CRB Administration Recommendation confirming that the proposed MDP amendment is consistent with the policies and principles of the CRB's Growth Plan and evaluation criteria in the REF. The third party consultant (Stantec) also recommended the approval of the MDP amendment.

CRB Administration indicated that based on legal advice obtained in 2011, Administration did not accept a REF application for an amendment to the IDP because the IDP is not considered a Statutory Plan pursuant to the Municipal Government Act since the IDP does not have support of the two participating parties.

**Motion:** That the Capital Region Board approves the proposed amendment to the St. Albert Municipal Development Plan in accordance with the Regional Evaluation Framework.

## Moved by Mayor Crouse.

21 in favour, 3 opposed. Supported by 17 or more municipalities comprising more than 75 percent of the population. **Motion carried.** 

## 6. Housing

a. Our Affordable Future Report

Mayor Fisher introduced the item thanking the private sector participants, elected officials and administration that were involved in the project to produce the Report.
