Re: Referral of *Our Complete Community*: Town of Beaumont Municipal Development Plan (Bylaw 887-17)

We are pleased to submit our new Municipal Development Plan known as *Our Complete Community* for review and consideration by the Capital Region Board through the Regional Evaluation Framework established under Ministerial Order L: 270/10.

Our Complete Community was prepared in conformance with Section 632 of the *Municipal Government Act*. The plan is forward thinking, as it is consistent with the 2010 Capital Region Growth Plan, while also meeting the objectives and policies of the forthcoming Edmonton Metropolitan Region Growth Plan, and other policies and strategies of the Capital Region Board of which Beaumont is an active member.

Our Complete Community received first reading on April 25, 2017, a statutory Public Hearing was held on May 23, 2017, and second reading was given on June 13, 2017. This plan was prepared collaboratively with Stantec Consulting with input from ISL Engineering and Land Services and Aaron Aubin Consulting. *Our Complete Community* is being referred to the Capital Region Board as part of the Regional Evaluation Framework established under Ministerial Order L: 270/10, Section 3.1 which states:

- 3.1 A municipality must refer to the Board any proposed new Intermunicipal Development Plan, Municipal Development Plan and any proposed amendment to an Intermunicipal Development Plan or Municipal Development Plan.

This application includes the following information, pursuant to Section 3.5 of the Regional Evaluation Framework:

- 1) *Our Complete Community*, Beaumont's Municipal Development Plan and Administration's memorandum to Council for second reading; and
- 2) a copy of the most recently amended Municipal Development Plan.
