b. Coal Community Transition Fund

Moved by Councillor Turton that the City of Spruce Grove submit an application to the Coal Community Transition Fund in the amount of \$600,000 to support the next stage of project definition and feasibility assessment on the proposed Sport and Event Centre as an important component of Spruce Grove's economic diversification strategy.

c. Support for Trans Mountain Expansion Project

275-17 (CM)

Moved by Councillor Gruhlke that;

WHEREAS energy and its related products are a significant part of Canada's annual exports which, along with metals and mineral products, represent the single largest positive annual contribution to Canada's balance of trade; and

WHEREAS the National Energy Board (NEB) determined the Trans Mountain Expansion Project (TMEP) is in the Canadian public interest; and,

WHEREAS the Federal Governor in Council approved of the project application on November 29, 2016; and,

WHEREAS the Conference Board of Canada conservatively estimates \$46.7 billion will find its way into government treasuries in the form of taxes and royalties from the TMEP during development and over the first 20 years of operations; and,



WHEREAS economic benefits generated during construction and 20 years of operations from the TMEP include:

- \$68.3 billion in additional revenue to Alberta oil producers attributable to Trans Mountain as a result of higher netbacks, over the first 20 years of operations
- \$45 billion GDP effects for Alberta; and

WHEREAS in addition to benefits created by the TMEP, operations of the expanded Trans Mountain Pipeline will generate \$3.3 billion in taxes over 20 years, with Alberta receiving a \$567-million share; and

WHEREAS local and regional property tax payments are estimated to go up by a total of \$3.4 million per year, a 116 per cent increase along the Alberta section of the route.

WHEREAS the process does not supercede the importance of the individual land rights.

THEREFORE BE IT RESOLVED that the City of Spruce Grove formally request that the Alberta Urban Municipalities Association urge the Government of Alberta to continue to support the Trans Mountain Expansion Project so it can meet its commitments to delivering jobs and economic benefits and meeting its regulatory requirements during the construction and operation of the pipeline; and

FURTHER BE IT RESOLVED that the City of Spruce Grove formally request that the Alberta Urban Municipalities Association urge the Federal Government to ensure that all regulatory processes that have been recommended for approval by the NEB and subsequently authorized by the Federal Governor in Council are permitted to proceed; and

FURTHER BE IT RESOLVED that the City of Spruce Grove formally request that the Alberta Urban Municipalities Association urge the Federal Government to exercise ancillary powers in order to enact the comprehensive regulatory scheme for the Canadian public interest, including the right to timely permitting, thereby enabling the commencement of construction.
